## **Job Summary:**

The Kamloops Branch of the Canadian Mental Health Association ("CMHA-KB"), a non-profit organization, is an independent society acting within a federated model and operating in the context of the nation-wide Strategic Plan for the Canadian Mental Health Association.

The Branch provides community education and advocacy aimed at the promotion of mental health and supporting individuals with mental illness and their families.

As a member of the Board of Directors, you will provide governance and oversight for CMHA Kamloops' strategic direction, ensure the integrity of the organization's operations, and contribute to its financial sustainability. Board members are expected to actively participate in meetings, contribute their expertise, and promote the organization's mission and goals.

This is an unpaid, voluntary position.

#### **Governance and Oversight**

- Ensure that CMHA Kamloops operates in compliance with applicable laws and regulations.
- Assist in setting and guiding the overall direction of the organization in line with CMHA's mission and strategic goals.
- Approve annual budgets and monitor financial performance.
- Oversee the implementation of CMHA's strategic and operational plans.

## **Community Engagement**

- Act as an ambassador for CMHA Kamloops, representing the organization at community events and with stakeholders.
- Establish and maintain relationships with community members, Indigenous leaders, funders, politicians, and partner organizations.
- Advocate for mental health issues within the community and promote CMHA Kamloops' services.

### **Fundraising and Resource Development**

- Participate in the development and execution of fundraising strategies.
- Identify and cultivate potential donors and funding opportunities to support CMHA Kamloops' programs.

#### **Monitoring Organizational Impact**

Regularly review the organization's progress in achieving its mission and objectives. Assess the impact
of CMHA Kamloops' programs and services on the community and ensure ongoing improvement.

## **Risk Management**

• Identify, evaluate, and address risks to the organization, including legal, financial, and reputational risks. Work with other board members to develop and implement risk management strategies.

#### Strategic Planning

• Contribute to the development and regular review of the organization's strategic plan to ensure alignment with CMHA Kamloops' mission and vision. Provide input on long-term goals and objectives.

## **Fostering a Positive Organizational Culture**

• Promote a supportive, inclusive, and transparent culture within the organization. Ensure the organization's values are reflected in all board activities and decisions.

# **Board Participation**

- Attend at least 75% of all board and committee meetings.
- Serve on committees or task forces and offer to take on special assignments.
- Actively contribute to discussions, decision-making, and problem-solving within the board.
- Participate in the annual board evaluation and strategic planning sessions.

- Board members serve a three-year term, renewable based on performance and commitment.
- Attend a minimum of 75% of board meetings annually and actively engage in organizational activities.
- Be available for ad-hoc meetings or tasks, depending on the organization's needs.
